- 2) The outer cover of the envelop should be super scribed as “ Quotation for **Purchase of Electrical Items for Electrical section of Workshop, IACS.**, Tender No. , last date of Submission, date of opening, Vendor’s address, etc.
- 3) The quotation submitted shall remain valid at least 90 days. from the date of opening the quotation.
- 4) **The rate should be mentioned with HSN code, GST % (CGST & SGST), with GST No & GST Certificate. Trade license copy has to be furnished. The price should be inclusive of transportation etc. The bid to be submitted as per the Price bid format in the Tender form. Nothing extra will be paid in addition to the quoted rate. Price should quote in Indian Rupee.**
- 5) In the event of date being declared a closed holiday for purchaser’s office, the due date for submission of quotation & its opening will be the following working day at the appointed time.
- 6) Payment: Within 90 days from the date of bill submission with accepted Material from store/Indenter fully.
- 7) Acceptance of Quotation: IACS authority does not bind itself to accept the lowest quotation & reserves the right to reject any or all the quotations received without assigning any reason thereof in the interest of IACS.
- 8) Installation / Demonstration etc. to be done against free of cost.
- 9) Supplier should provide copy of PAN No. , GSTIN No. & Trade License No. etc. along with sealed quotation failing which the tender will summarily be rejected.
