CORRIGENDUM

TO

THE TENDER NOTICE: NIT NO: IACS/SECURITY/2018-19/001 DATED
10.08.2018

The Security Tender Committee after pre-bid meeting resolved to make the following modifications in the said Tender Notice:-

- 1) **Read as** : **At Page 1 point 5** Estimated cost of Rs.2,00,00,000/- (Rupees Two Crore) per annum.
2) **Add** : **At Page 5 below point 22 add the following:-**

23. The Security Guards will not be allowed to form any kind of Union/Association in the Institute during their contract or would not be allowed to involve in any activities which may damage the reputation/discipline of the Institute.

24. In case of any theft/loss of property of the Institute caused during the duty of the security personnel or any act inviting legal disputes arises during the course of duty, would invariably be reported to the Institute authority immediately and the concerned Security Supervisor/Head of the Agency will take an initiative to lodge the Complain/General Diary/FIR with the nearest Police Station after the report/complaint is forwarded by the Security Officer and concurred by the IACS authority.

At Page 6 (Check List) below point 18 add the following:-

19. Whether the Agency is empanelled with the Office of the DGR:

- 3) **Read as** : At Page 7 (Technical Bid) at point 5, in place of 60 read all as 100.

- 4) **Add** : Page 11 at point 6(ii) in third line at the end after educational Qualifications **add** police verification

- 5) **Add** : **At Page 17 (Documents to be submitted) after point 18 add point 19 as follows:**

19. A copy of the Registration Certificate of the empanelment of the Agency with DGR to be enclosed.

6) **Delete** : **At Page 21** (Agency's Obligations) **at point 2**, delete **fourth and fifth** lines of the clause from : *"However, JCOs or equivalent rank having rendered 30 years or more defence service may be relaxed age by 5 years for the job of Security Supervisor"*.

7) **Add** : **At Page 1** after point **9** add point **9A** as follows:-

9A. All technically qualified bidders will invariably be required to give a power point presentation about their agency and their credibility in the market before the financial bid is opened. The presentation will carry some weightage for deciding opening of Financial Bids of the technically qualified bidders with weightage of presentation. The sole criteria of selection of the agency will not fully depend upon the lowest rates. The Institute will have all the rights to reject the lowest quotation if other criteria are not up to the mark as considered by the designated Committee.

The date and time of the presentation will be communicated to the technically qualified agencies in due course.
